A judging panel will select the finalists who will be exhibited in a dedicated gazebo during the 2025 ceramics festival. During the festival, the winning work will be awarded with a public ceremony.

The organization reserves the right to:

- acquire the winning work in the collections of the Civic Museum of Ceramics of Nove;
- use the image of the awarded work, also for the promotion of the 2025 edition of the Ceramics Festival;
- do not award the prize.

The author/ recipient of the winning work undertakes to deliver the work so that it may permanently enter the museum collections without any obligation and waives any right to the reproductions of his/her image.
